

Johnson and Johnson Vaccine

- Approved this weekend
- 1 dose vaccine
- Clinical trials found it was 100% effective at preventing hospitalization and death
- Clinical trials found it was effective in preventing against variants
- Side effects include pain at injection site, headache, and fatigue



MDH Updated Guidance for Allocating and Prioritizing COVID-19 Vaccines

- The <u>updated guidance for Phase 1a</u> clarifies settings and populations included the current vaccine efforts in Phase 1a.
- It specifically identifies congregate settings on the homeless service continuum, domestic violence settings, people who are unsheltered and homeless service providers in phase 1a – third priority.
- This updated guidance clarifies the work that is underway and does not change the any of the current efforts to vaccinate people living or working in congregate homeless service settings.





- The Food and Drug Administration (FDA) approved the emergency use authorization (EUA) for the Johnson & Johnson sign dose vaccine on February 27. Janssen, the drug manufacturer, has a <u>handout with information on the vaccine</u>. The Urban Indian Health Institute has developed a 2-page handout for the <u>Moderna</u> and <u>Pfizer</u> vaccines.



Federal COVID-19 Relief Bill - "American Rescue Plan Act"

- \$1.9 trillion coronavirus relief bill includes over \$40 billion in housing and homelessness resources. A summary of items included are:
 - \$19.05 billion for emergency rental assistance
 - \$5 billion for emergency housing vouchers
 - \$5 billion for homelessness assistance
 - \$9.96 billion for homeowner assistance to avoid foreclosure
 - \$100 million for housing counseling
- The National Low Income Housing Coalition <u>detailed summary</u> of the housing provisions currently included in the bill.
- The National Council of State Housing Agencies shared a <u>summary of the Homeless</u> Assistance and Supportive Services Program Under HOME.
