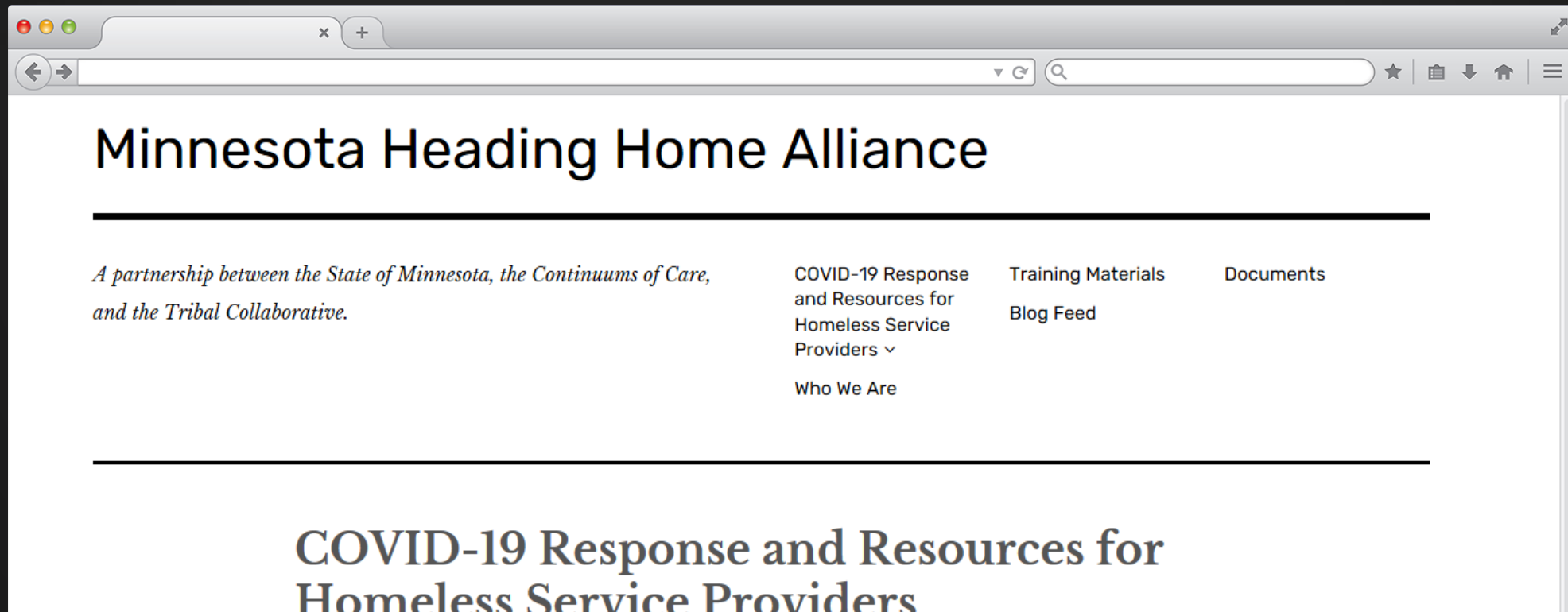

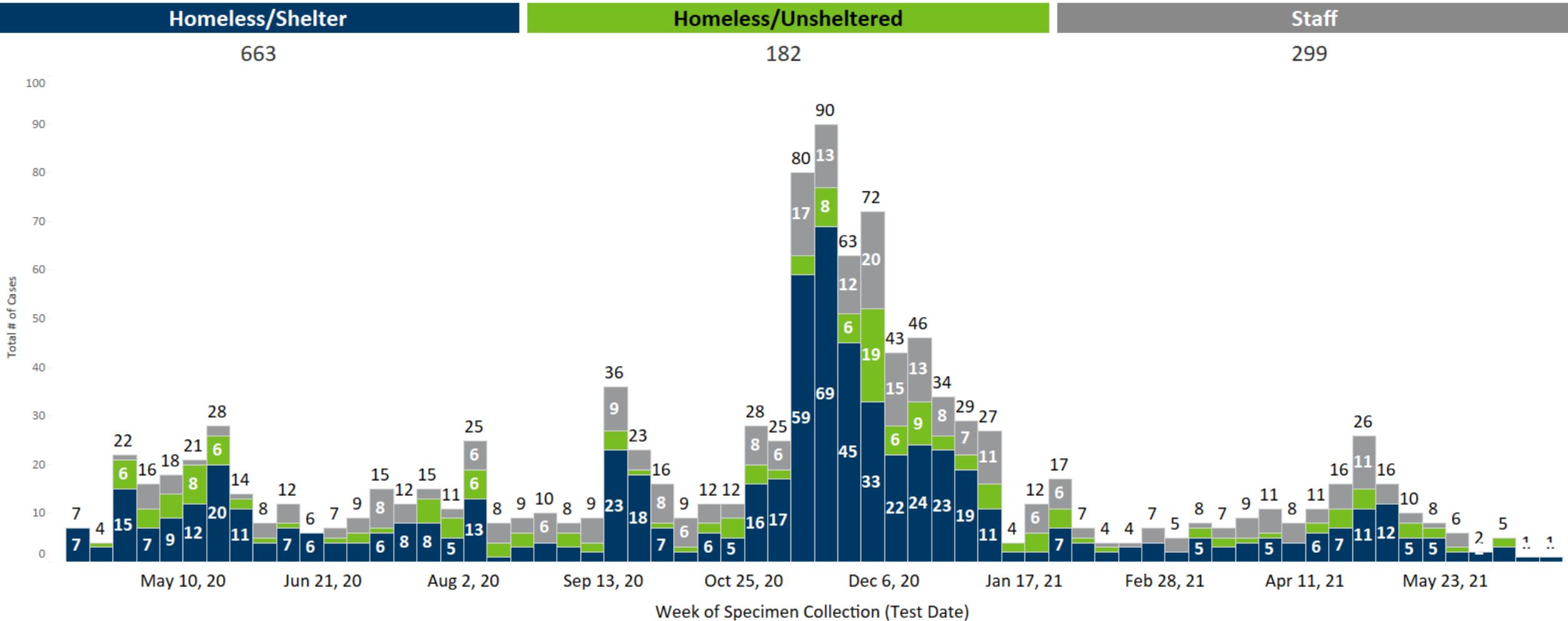

	Get tested 1-3 days before travel	✓
Get tested 3-5 days after travel and self-quarantine for 7 days. Self-quarantine for 10 days if you don't get tested.	✓	
Self-monitor for symptoms	✓	✓
Wear a mask and take other precautions during travel	✓	✓

Get tested 1-3 days before traveling out of the US	✓	
Mandatory test required before flying to US	✓	✓
Get tested 3-5 days after travel	✓	✓
Self-quarantine after travel for 7 days with a negative test or 10 days without test	✓	
Self-monitor for symptoms	✓	✓
Wear a mask and take other precautions during travel	✓	✓

MDVA Diversity, Equity, and Inclusion Workgroup

- MDVA has engaged with [Racial Equity Partners](#) (REP) to create a workgroup that will meet quarterly over the next year to shape MDVA's racial equity work. The workgroup's purpose is to develop a more profound and richer information about the culture within agencies in the State of Minnesota, understand the experiences of staff on the front lines of the work, and hear what is most important to you to see agencies in the state of Minnesota serve as the thought leaders and implementers for equity-based homelessness solutions.
- MDVA is looking for 15-20 people to participate in the Racial Equity Workgroup. If you are interested in participating in the Racial Equity Workgroup, please note that MDVA is seeking:
 - Representation from across the state.
 - Individuals who are passionate about racial equity and interested in exploring strategies to understand diversity, equity, and inclusion as it relates to the efforts to ending veteran homelessness.
 - Individuals who identify as Black, Brown, Indigenous, or people of color (51-60%).
 - Veterans with lived experience—not to exceed up to a year post homelessness.
 - Individuals who identify as LGBTQ.
 - Individuals at all levels of organizational structure.

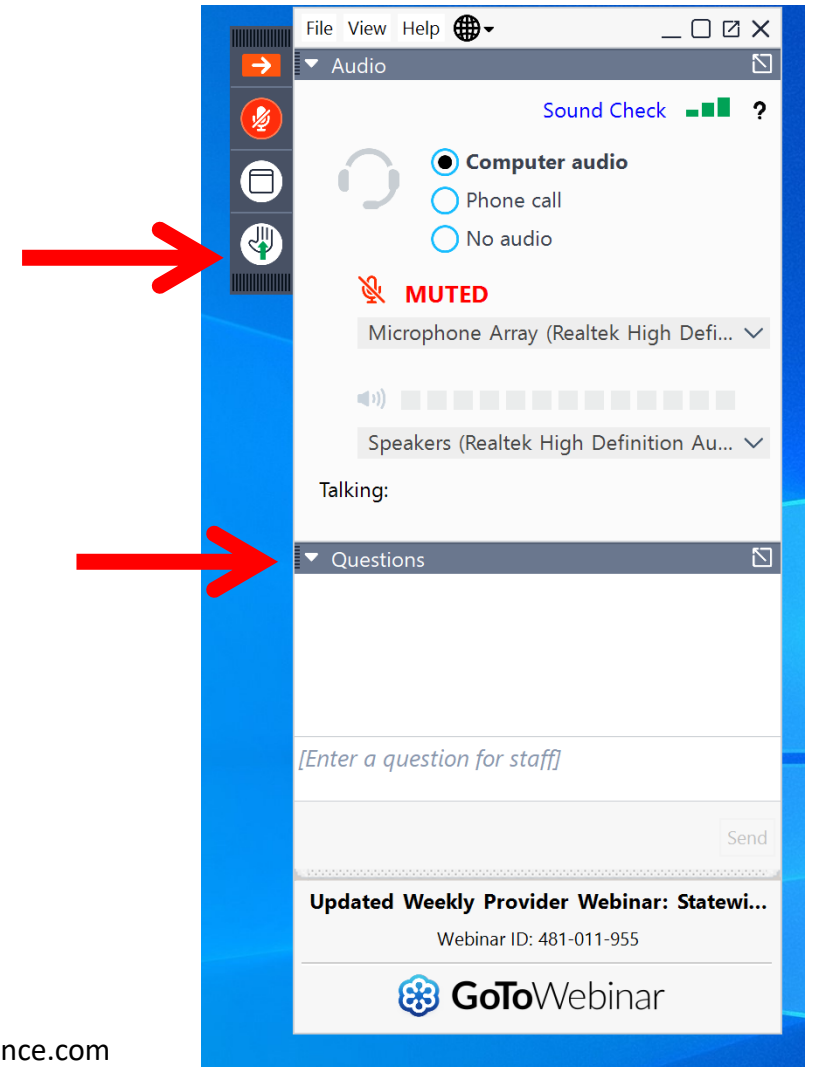
- Workgroup meetings are scheduled for the 3rd Monday of each quarter from 1:00 -4:00 p.m. CT on the following dates.
